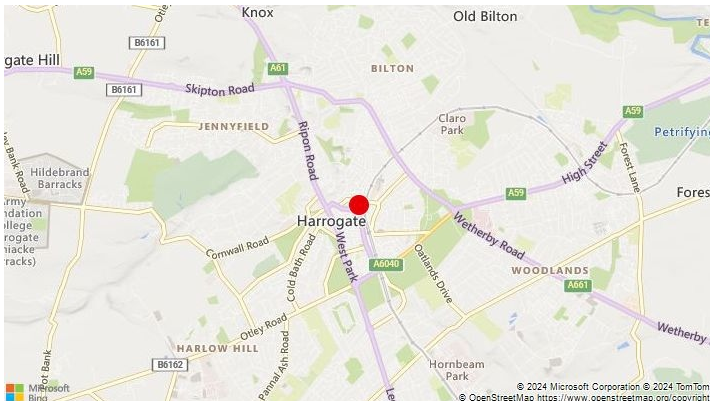

The business is currently operating below its full potential due to the owners' circumstances. A new owner could significantly increase turnover by fully exploiting the business's capabilities. Additionally, re-establishing magazine and newspaper sales would be relatively straightforward.
